

WARREN COUNTY ELECTORAL BOARD MEETING
Wednesday, November 3, 2021
Canvas of the November 2, 2021 General and Special Elections

The Warren County Electoral Board met on Wednesday, November 3, 2021 at 10:00 a.m. for the Canvas of the November 2, 2021 General and Special Elections. Members in attendance were Marilyn King, Chairman; Robert "Bob" Hill, Vice-Chair; and Lee Bowen, Secretary. Carol Tobin, Director of Elections and General Registrar was available when and if needed.

The first order of business was the Provisional Ballot Meeting. No one from the public was present. It was determined that 24 Provisional Ballots were cast; however, research needed to be done for numerous ballots along with waiting for the deadline of noon on Friday, November 5, 2021 (the third day after the Election) for returned mailed ballots received after the Election and postmarked no later than November 2, 2021 to determine if those ballots could be counted.

The members moved to continue with the Canvas of the Election. They reviewed each precinct results to make sure all the information from the SORs and tapes matched what had been reported during Election night reporting and the results had been captured correctly. Several Officers were called to come in and sign documents.

There were three write-in campaigns. Two write-in candidates for Member, Board of Supervisor for Fork District and one write-in candidate for Member, School Board Fork District. The Board proceeded with processing the Write-in report from each Fork District Precinct. This required listing the name and the number of votes they received.

The Electoral Board recessed the canvas and will meet again on Thursday, November 4, 2021 to continue with the write-in reports and counts.

The Electoral Board resumed their meeting on Thursday, November 4 at 9:30 a.m. to finish the Write-in Count and report. The meeting was recessed and will resume at 2:00 p.m. on Friday November 5, 2021.

The Electoral Board resumed its Provisional Ballot Meeting on November 5, 2021 at 2:00 P.M. The following members were in attendance Marilyn King, Chairman; Bob Hill, Vice Chair; and Lee Bowen, Secretary. Carol Tobin, Director of Elections and General Registrar was also in attendance. The Board went into closed session Bob Hill made the motion to go into closed session and Marilyn King seconded. Two authorized representatives were present during the meeting. 18 provisional ballots were cast and counted.

The meeting then moved back to open session at 2:35 p.m. It was agreed that the Electoral Board would recess and reconvene on Monday, November 8, 2021 at 10:15 a.m. to sign and attest the Abstracts.
