Electoral Board Meeting Minutes Canvas of June 17, 2025, June Primary Elections June 18, 2025

The Meeting was called to order at 10:35 am, June 18, 2025. Electoral Board Members present were Marilyn King, Chair, and Lee Bowen Secretary. Matthew Reisinger, Director of Elections and General Registrar, was also present. One member of the press, Roger Bianchini, was present.

The Electoral Board presented Matthew Reisinger, General Registrar, with the provisional ballots that needed to be researched and requested the General Registrar provide information whether they qualified. The provisional portion of the meeting was adjourned until Monday, June 23, 2025, at 10:00am to allow time for ELECT to run the post-election provisional duplicate report. The Electoral Board adjourned at 11:00am for lunch and reconvened at 12:30pm to continue the Canvass of the election. The board adjourned for the day at 2:10pm until Monday, June 23, 2025, at 10:00am.

On Friday, June 20, 2025, the CAP (Central Absentee Precinct) met to count any post-election ballots received that were post-marked on or by Election Day and received by noon the third day after the Election.

The Electoral Board reconvened on Monday June 23, 2025, at 10:20am. The motion was then made, and the board entered a closed session to review qualifying information provided by the General Registrar for the provisional ballots. The board came out of closed session to count the provisional ballots.

A total of 11 provisional ballots were counted by the board:

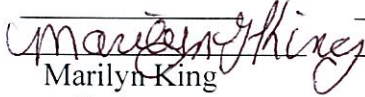

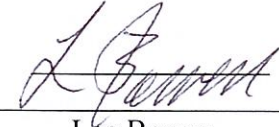
