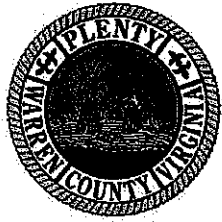

Wednesday, January 7, 2026

Meeting called to Order at 10:00 am

Board Members Present: Marilyn King, Marc Nelson and Lee Bowen.

Election of Officers:

Mr. Reisinger called for the nomination for the position of Chair, Mr. Bowen nominated Ms. King.

Additional New Business:

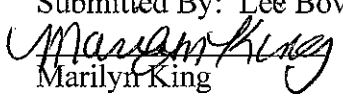
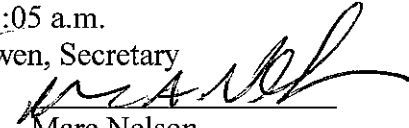
The Board expressed interest in all members attending the annual VEBA Conference in March.
