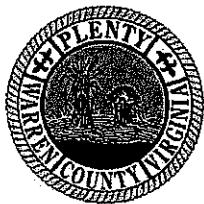

Meeting of the Warren County Electoral Board

Tuesday, April 7, 2026

Meeting called to Order at 10:00 am

Board Members Present: Marilyn King, Marc Nelson, and Lee Bowen.

Adoption of Agenda:

On a motion by Mr. Bowen, seconded by Mr. Nelson, the Board approved the meeting agenda as presented.

Motion passed 3-0.

Motion Closed Meeting: Motion was made to go into closed session by Mr. Bowen seconded by Mrs. King. Motion passed 3-0. Section 2.2-3711 (A)(34) – for purpose of the Annual Locality Election Security Audit.

Certifying to the best of each member's knowledge only public business matters lawfully exempted from open meeting requirements of the Virginia Freedom of Information Act and only such public business matters by which the closed meeting was convened were heard, discussed, or considered in the meeting by the public body. Motion passed 3-0.

The next regular Electoral Board meeting will be held on Thursday, May 21, 2026, at 10:00am.

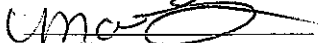

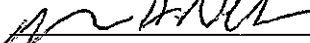
Meeting Adjourned:

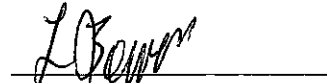
Mr. Bowen made a motion seconded by Mrs. King to adjourn. Motion passed 3-0.
